PROPOSED SPRINGDALE SOLAR FARM

This newsletter aims to provide ongoing updates to the local community for the Springdale Solar Farm proposal.

'RESPONSE TO SUBMISSIONS' SUBMITTED

RES submitted the Response to Submissions (RtS), planning report, to NSW Department of Planning, Industry and Environment (DPIE) on 31 May 2020. DPIE accepted the RtS and put it on public display on 2 June 2020.

DPIE will now spend several week reviewing and seeking feedback from the agency consultees before completing their planning assessment of the solar project. The completed Assessment Report will be available for public review and will also be passed to the Independent Planning Commission (IPC) for the next stage of Springdale Solar Farm's planning process. The IPC will be the consent authority for Springdale Solar Farm, following the project's receipt of more than 25 objections.




INDICATIVE TIMELINE:

PROJECT CHANGES - LAYOUT & DURATION

Following review of community and stakeholder feedback, RES have made where possible, adjustments to the project. These changes are set out in detail in a separate planning report also submitted to DPIE on 31 May 2020. The Amendment Report is also available for review on DPIE's major project website.

Project changes include; the reduction in the overall solar panel area, reorientation of the substation with additional asset protection zone, reconfiguration of internal tracks linking the solar development areas and an extension in the operational life of the project from 30 years to 35 years.
